What we collect and what we do with the information we gather

SOS Hygiene Technologies Limited is committed to ensuring that your privacy is protected and does not require a visitor to provide any personal information (such as name, address, telephone number or email, or credit card number) to access its web sites and view information about the company, its products or its services. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

SOS Hygiene Technologies may collect certain general information from every visitor, such as web pages you view.

We require this information to understand your needs and provide you with a better service, and for the following reasons

Security

We are committed to ensuring that your information is secure. In order, to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.
